PRODUCT ADDENDUM

LIFENET® System

Stryker will provide Customer access to the LIFENET System and its associated applications and infrastructure, including LIFENET Alert, LIFENET Archive, LIFENET Asset, LIFENET Adapter, LIFENET Consult, LIFENET Export, LIFENET OnePush or LIFENET PC Gateway Software as set forth in the Ordering Document and as described at https://www.stryker.com/us/en/emergency-care/data-solutions.html subject to the terms of the preceding Software and Hosting Terms and Conditions and the following product-specific terms and conditions:

- 1. USE RIGHTS FOR LIFENET SUBSCRIPTIONS. The LIFENET Unlimited Subscription, the LIFENET Standard Subscription and the LIFENET Basic Subscription include a license for unlimited Users to use software necessary for receiving data from the LIFENET System (the "Receiving Software"). Stryker grants to each LIFENET Unlimited, LIFENET Standard and LIFENET Basic Subscriber a license according to the preceding Software and Hosting Terms and Conditions to use the applicable Receiving Software in accordance with the following:
 - 1.1. **LIFENET Unlimited**. Each LIFENET Unlimited Subscription allows a Customer to install the following applications on an unlimited number of personal computers at a single location at a Permitted Facility in the United States: LIFENET Alert, LIFENET Archive, LIFENET Export, and LIFENET Adapter. In addition, LIFENET Unlimited also allows for an unlimited number of LIFENET Consult Users. LIFENET Unlimited Subscriptions also entitle Customer to purchase and use LIFENET OnePush and LIFENET Cardiology Cart Integration licenses.
 - 1.2. LIFENET Standard. Each LIFENET Standard Subscription allows a Customer to install the following applications at a single location at a Permitted Facility in the United States: LIFENET Alert on three (3) personal computers, with the option of LIFENET Archive, LIFENET Export on one (1) personal computer, and up to five (5) LIFENET Consult Users.
 - 1.3. **LIFENET Basic**. Each LIFENET Basic Subscription allows a Customer to install the following applications at a single location at a Permitted Facility in the United States: LIFENET Alert on one (1) personal computer with the option of LIFENET Archive.

Multiple licenses are required to install the application throughout a hospital system with multiple locations. Concurrent use on multiple computers beyond the limits listed above requires a separate license for each computer/User.

2. USE RIGHTS FOR LIFENET APPS. For LIFENET applications that are (i) not purchased in connection with a LIFENET Unlimited,

LIFENET Standard, or LIFENET Basic Subscription or (ii) are purchased due to use right limitations of the applicable LIFENET System subscriptions, the following use rights apply.

- 2.1. For each LIFENET Alert, LIFENET Adapter, LIFENET Archive, or LIFENET PC Gateway Software license purchased, Customer may install one copy of the Stryker Software to operate on one computer or device, and one copy for backup or archival purposes at a single location at a Permitted Facility in the United States.
- 2.2. LIFENET Consult and LIFENET Export are only available through a LIFENET Unlimited or LIFENET Standard Subscription. For each additional license purchased, Customer may install one copy of the Stryker Software to operate on one computer or device, and one copy for backup or archival purposes at a single location at a Permitted Facility in the United States.

Multiple licenses are required to install the application throughout a hospital system with multiple locations. Concurrent use on multiple computers beyond the limits listed above requires a separate license for each computer/User.

- 3. LIFENET ADAPTER. LIFENET Adapter may only be installed on equipment located at the Customer's location. Stryker is not responsible for the breach of any third-party end-user agreement that Customer may have entered into or accepted by the purchase and use of a monitor or 12-lead system that was not supplied to Customer by Stryker. Stryker is only providing the LIFENET Adapter and it is Customer's responsibility to ensure the ability to export 12-lead ECG data from Customer's system to the LIFENET System via the LIFENET Adapter.
- **4. ECG DATA**. The LIFENET System is not an electronic medical record. Customer is responsible for printing any ECG Data as may be necessary or appropriate to include in any patient's medical record. ECG Data is stored on the LIFENET System and is accessible by certain LIFENET products for a customer-defined time period.

Stryker will provide Customer access to the LIFENET Care and its associated applications and infrastructure, including LIFENET Asset, LIFENET Adapter, LIFENET Care app, or LIFENET Tablet Gateway Software as set forth in the Ordering Document and as described at <u>https://www.stryker.com/us/en/emergency-care/data-solutions.html</u> subject to the terms of the preceding Software and Hosting Terms and the following product-specific terms and conditions:

- 1. **USE RIGHTS FOR LIFENET CARE SUBSCRIPTIONS**. The LIFENET Care Pro, the LIFENET Care Standard, and the LIFENET Care EMS Pro Subscriptions include a license for Users to use software necessary for receiving data from the LIFENET System in accordance with the following:
- 1.1. **LIFENET Care Pro**. Each LIFENET Care Pro Subscription is priced based on the bed size of the facility, or the number of hospitals for the enterprise subscription. Each licensed facility has unlimited logins to the LIFENET Care browser application and LIFENET Care app. The LIFENET

Care client can be installed on unlimited number of Windows computers. LIFENET Care Pro also includes hospital EMR integration via Redox, Stryker's third-party partner. CODE STAT licenses are bundled in the LIFENET Care Pro subscription and vary based on tier quoted.

- **1.2. LIFENET Care Standard**. Each LIFENET Care Standard Subscription is packaged based on the bed size of the facility, or the number of hospitals for the enterprise subscription. Each licensed facility has unlimited logins to the LIFENET Care browser application and LIFENET Care app. The LIFENET Care client can be installed on unlimited number of Windows computers.
- 1.3. LIFENET Care EMS Pro. Each LIFENET Care EMS Pro Subscription is packaged based on the total run volume of the agency and is quoted per agency. This package includes account setup tools, EMS to hospital communication via the LIFENET Care platform and allows for LIFEPAK 15 device live steaming. CODE STAT licenses are bundled in the LIFENET Care EMS Pro subscription and vary based on tier quoted.

Unless an enterprise subscription is purchased, multiple licenses are required to access LIFENET Care throughout a hospital system with multiple locations.

2. USE RIGHTS FOR OTHER LIFENET RELATED

APPICATIONS. For LIFENET applications that are (i) not purchased in connection with a LIFENET Care Pro, LIFENET Care Standard, or LIFENET Care EMS Pro Subscriptions or (ii) are purchased due to use right limitations of the applicable LIFENET System subscriptions, the following use rights apply.

2.1. For each LIFENET Gateway Software license purchased, Customer may install one copy of the Stryker Software to operate on one computer or device, and one copy for backup or archival purposes at a single location at a Permitted Facility in the United States.

Multiple licenses are required to install the application throughout a hospital system with multiple locations. Concurrent use on multiple computers beyond the limits listed above requires a separate license for each computer/User.

3. **LIFENET ADAPTER.** If the LIFENET Care subscription is being used in connection with Stryker's monitors/defibrillators, then LIFENET Adapter may only be installed on equipment located at the Customer's location. Stryker is not responsible for the

breach of any third-party end-user agreement that Customer may have entered into or accepted by the purchase and use of a monitor or 12-lead system that was not supplied to Customer by Stryker. Stryker is only providing the LIFENET Adapter and it is Customer's responsibility to ensure the ability to export 12-lead ECG data from Customer's system to the LIFENET System via the LIFENET Adapter.

If the LIFENET Care subscription is being used in connection with non-Stryker monitors/defibrillators, then Stryker shall provide a cloud-based LIFENET Adapter. Stryker is not responsible for the breach of any third-party end-user agreement that Customer may have entered into or accepted by the purchase and use of a monitor or 12-lead system that was not supplied to Customer by Stryker. Stryker is only providing the LIFENET Adapter and it is Customer's responsibility to ensure the ability to export 12-lead ECG data from Customer's system to the LIFENET System via the LIFENET Adapter.

- 4. **ECG DATA.** LIFENET Care is not an electronic medical record. LIFENET Care Standard customers are responsible for printing any ECG Data as may be necessary or appropriate to include in any patient's medical record. ECG Data is stored on the LIFENET System and is accessible by certain LIFENET products for a customer-defined time period.
- 5. **Implementation; Training; Technical Support.** Customer is entitled to remote implementation and training associated with purchased Subscriptions. Stryker agrees to make commercially reasonable efforts to: (i) commence implementation of the software necessary to establish communication with the LIFENET System in accordance with a mutually agreed upon schedule; (ii) diligently perform the implementation process in a professional and workmanlike manner; (iii) provide the training associated with purchased subscriptions, components and/or software; and (iv) provide access to technical support.

Customer agrees to cooperate with and assist Stryker in the implementation process.

Customer agrees to have all equipment, connections and facilities prepared and ready for implementation in accordance with the mutually agreed upon schedule.

Implementation is complete when Customer is able to transmit data to or receive data from (as applicable) the LIFENET System.
