Instructions for use

Remove the Knee Cushion and Calf Cradles from the bag

Place the Knee Cushion under the patient's knee(s)

Avoid hyperextension of the knee(s).

Caution: To avoid potential injury, do not use Calf Cradles without Knee Cushion.

Note: If using Sequential Compression Device (SCD), apply SCD sleeve(s) prior to placement of Calf Cradles.




Open the spandex flaps of each Calf Cradle

With the blue sides facing down, slide Calf Cradles under patient's leg(s) until centered on the black strips. Ensure the bottom of each Calf Cradle is under the patient's Achilles.

Ensure the top of each Calf Cradle is under the patient's calf.

If only one Calf Cradle is needed, disconnect the Calf Cradles at the Connecting Buckle. Dispose of the unused Calf Cradle.




Close the spandex flaps around each leg to secure the Calf Cradle

Caution: Check tightness of Calf Cradles according to hospital protocol. **Caution**: If using SCD, ensure tubing is not kinked or contacting skin.



Patient's heels should not be in contact with the table surface

If heels contact table, move Calf Cradles toward feet until heels are floated.




Anchor Calf Cradles to OR table rails with black and white Calf Cradle Side Straps



Before transferring patient, release Side Straps

Release Connecting Buckle to separate Calf Cradles. Transfer patient to OR table, bed, or stretcher.



If product become soiled, dispose of product once surgery is completed

Otherwise, dispose of product after recovery phase.
