Indications of Use:

Suction Toothbrush: Aids in the removal of dental plaque, debris, and oral secretions.

Suction Swab: Aids in the removal of oral secretions and debris.

Instructions for Use:

Suction Toothbrush: Burst solution packet with thumbs. Peel package open. Attach Suction Toothbrush to suction line. Brush teeth and oral cavity for 1 minute. To suction, place thumb over port. Rinse to clear tubing after use. Discard according to hospital protocol and local regulations.

Suction Swab: Burst solution packet with thumbs. Peel package open. Attach Suction Swab to suction line. Clean mouth for 1 minute. To suction, place thumb over port. Rinse to clear tubing after use. Discard according to hospital protocol and local regulations.

Corinz Oral Rinse: Children under 3 years of age: Consult a dentist or doctor. Children under 12 years of age: Supervise use. Use under the guidance of a healthcare professional. Discard according to hospital protocol and local regulations. Keep out of reach of children.
