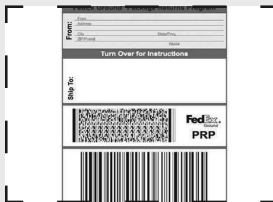

Authorized Contents: The RETURNPAK Cactus® Sink Cartridge Prepaid Return Shipping & Disposal Program is approved for the shipment of four (4) used cartridges including two (2) solid cartridges and two (2) liquid cartridges.

Original manufacturer packaging must be used for this supply code. IF YOU DO NOT HAVE THE ORIGINAL MANUFACTURE PACKAGING FROM STRYKER INSTRUMENTS, DO NOT USE THIS PRODUCT. See Supply-377 or Supply-378 which supplies the necessary packaging.
