Physician Office Eligibility

Special pricing for AlloWrap®, BioSkin®, and ViaFlow® in the physician office setting (Site of Service 11) is available. To qualify for this pricing, applicable accounts must meet the below eligibility criteria:

- Eligible physician offices must be free standing. They cannot be owned, leased, or managed by an Integrated Delivery Network (IDN) or other Ambulatory Surgery Center (ASC) group
- Physician office must have an established account number within JDE or Oracle
- A copy of the account's W9 is required
- Accounts must pass a credit check

Please be sure to confirm that your physician office is not owned, leased, or managed by an IDN or other ASC group. To set up a new account, contact your Customer Service Representative (CSR).


AlloWrap DS may be reported separately with Healthcare Common Procedure Coding System (HCPCS) code **Q4150** – **AlloWrap DS, pre-hydrated or dry**, per sq cm. HCPCS code Q4150 is not included in the Average Sales Price (ASP) Medicare Part B Drug Pricing File. The Medicare payment allowance limit for drugs and biologics not included in the ASP file is based on the published Wholesale Acquisition Cost (WAC) or invoice pricing for physician payment. Therefore, Medicare payment for HCPCS code Q4150 will be based on WAC or invoice in the physician office setting.



BioSkin®

Amniotic Wound Matrix

BioSkin may be reported separately with Healthcare Common Procedure Coding System (HCPCS) code **Q4163 - Woundex**, **BioSkin**, **per sq cm**. The Centers for Medicare & Medicaid Service (CMS) has provided updated guidance for the Average Selling Price (ASP) specific to BioSkin, which is now \$148.55 per sq. cm. As a result, the purchase price for BioSkin for use in the physician office setting (Site of Service 11) is \$148.55 per sq. cm. This price is good for in-office applications only for Q2 2022, ending June 30, 2022. Any changes from CMS will be provided in an update for Q3 2022, if necessary.
